Dear Speaker Figirlaarwon:

I am transmitting herewith **Bill No. 11-55, D1**, entitled, "To appropriate the sum of \$14,000, the balance of funds previously appropriated under Yap State Law No. 11-17, from the Special Revenue Fund for the purpose of funding the Yap Main Island Roadside Maintenance project during Fiscal Year 2024, and for other purposes," which may be henceforth be cited as **Yap State Law No. 11-48**; and

**Bill No. 11-57**, entitled, "To amend Yap State Law No. 11-31, by amending Section 2 thereof, for the purpose of modifying conditions and restrictions of funds therein, and for other purposes," which may be henceforth be cited as **Yap State Law No. 11-49**; and

**Bill No. 11-62**, entitled, "To amend Yap State Law No. 11-20, by amending Section 2 for the purpose of authorizing Yap Visitors Bureau to administer funds appropriated therein, and for other purposes," which may be henceforth be cited as **Yap State Law No. 11-50**; and


**Bill No. 11-63**, entitled, "To appropriate the sum of \$3,021,734 from the Special Revenue Fund of the State of Yap for the purpose of providing partial funding derived from grants under the Second United States Continuing Resolution for government operations during Fiscal Year 2024, and for other purposes," which may be henceforth be cited as **Yap State Law No. 11-51**; and

**Bill No. 11-64, D1**, entitled, "To appropriate the sum of \$28,283 from the General Fund of the State of Yap for the purpose of providing funding to fund activities and programs relating to the 2024 Yap Day Celebration during Fiscal Year 2024, and for other purposes," which may henceforth be cited as **Yap State Law No. 11-52**.

All these Bills were passed by the Eleventh Legislature of the State of Yap, Second Regular Session.

Copies of this letter and the new state laws are hereby disseminated to other State authorities concerned so as to keep them informed and updated on the status of the referenced legislative measures.
